# Junior By-Laws

#### THE FOLLOWING RULES APPLY TO ALL REGISTERED PLAYERS/TEAMS IN THE <u>JUNIOR &</u> <u>INTERMEDIATE</u> SATURDAY MORNING NAMBUCCA VALLEY NETBALL COMPETITION:-

#### 1 **Registration**

You **<u>MUST</u>** be a registered player with Netball NSW through your affiliated Club or the Nambucca Valley Netball Association Inc. before taking part in any training or game.

Players wishing to register after the competition has started, shall complete the appropriate form made available at the courts and pay the appropriate fee before a game commences.

#### 2 Team Uniforms

- i) Each player <u>MUST</u> play in a similar playing uniform, which has been approved by the Committee:-
  - Same colour dresses, shirts, shorts / skirts must be worn by all team members.
  - Tops must extend past the top of your skirts/shorts.
  - All players must wear appropriate footwear.
- ii) One (1) warning will be given to players in a team if they are out of uniform. It will be written on the official score sheet and the Match Secretary informed. A two (2) goal deduction per player out of uniform will apply for the next breach of rules.
- 3 All players MUST wear identification patches. If two teams have the same coloured patches, different colours are available at the office.
- 4 Players may not wear anything that could endanger themselves or other players, specifically:(a) No adornment or jewellery may be worn. Studs are not permitted.
- (b) A wedding ring or medical alert bracelet may be worn provided it is covered with tape

- (c) Fingernails must be short and smooth
- (d) Hair must be suitably tied back.
- (e) Only prescription eyewear may be worn

(f) Players that are required to wear a piercing for medical reason (e.g. daith piercing for migraines) may tape this piercing only and take the court, provided they present the NVNA committee with a copy of a medical certificate which states the medical reason for the piercing.

- 5 For safety reasons, no hard brimmed hats will be permissible to wear during games.
- 6 A team cannot consist of more than twelve (12) players.
- 7 Boys are permitted to play up until the age of 12 years. The number of boys permitted on court in the Junior Age Division at any one time is as follows:-

11 or 12 years - 3 boys

- 8 At the beginning of each season, Clubs/Teams will play in a round robin and those teams will be graded by a grading Committee comprising of representatives of all Clubs and NVNA.
- 9 Children with a disability may be placed in a lower age group after consulting the Association and reviewed by the Executive Committee.

## 10 Umpires

- i) No official match will be played without two (2) umpires.
- Umpires have total control of the game. Any concerns about control and safety during the game should be directed to the on-court umpire mentor, Umpires Convenor or MPIO. No coach, spectator or player is to confront or question any umpire during play. Team captains <u>ONLY</u> may approach an umpire during any interval or after the game to clarify rules.
- iii) Players should approach an umpire during play if there is an emergency arising on court that the umpires are unaware of.

# 11 Official Score Sheet

- i) Players must supply a specimen signature at the beginning of the season on the team sheet and sign on for each match. Score sheets will be audited from time to time against samples kept by the Match Secretary and ineligible signatures will not count as matches play.
- ii) Each team must supply a responsible scorer for their match.
- iii) Team captains, a scorer from each team and umpires are to sign the score sheet.
- iv) The winner of the game is to take the score sheet to the office.
- v) Teams failing to sign the score sheet after the game must accept without challenge, the score sheet as completed by the opposing team.
- 12 Limit of five (5) Representative (Rep) Players in any one team are permitted to take the court at any time however, in special circumstances a team may use more than five (5) if team attendance is less than seven (7). This will be monitored throughout the season.

# Definition of a Rep Player

A Rep Player is a player who is representing the Nambucca Valley in the current year in either State Age, State League or State Championship teams. If a player is selected to play rep netball for the Nambucca Valley <u>after</u> the selection process and <u>after</u> the commencement of the season, the Executive Committee will have the discretion to deem that player a rep player or non-rep player.

#### 13 Match Requirements

i) A quorum for a game is **four (4)** registered players from each registered team. You cannot play with three team members and two borrowed players

ii) If you have four (4) original team members, you can borrow a maximum of three (3) players. If you have five (5) original team members you may borrow a maximum of two (2) players. If you have six (6) original team members you may borrow a maximum of one (1) player.

iii) If the original team members arrive late to a match, they **<u>MUST</u>** take the place of the borrowed players at the next centre pass. They must play the position currently being played by the borrowed player.

iv) All players <u>MUST</u> be filled out correctly on the score sheet. <u>THIS INCLUDES BORROWED</u> <u>PLAYERS</u>.

v) Players taking the court <u>MUST</u> appear on score sheet. Substitute name/s only to appear when coming on to play.

vi) If a rep player is requested to substitute on another team, **they are only able to play if they are replacing a rep player**.

vii) Failure to sign the score sheets appropriately may result in the game being deemed a forfeit and points awarded to the opposing team.

#### 14 Claiming Forfeits

- i A team may claim a forfeit two (2) minutes after the time set down for the commencement of the match if the opposing team does not have five (5) players ready to play including 4 players registered with that team.
- ii Teams claiming the forfeit must complete the score sheet as usual. Players of the team claiming the forfeit, whose names appear on the score sheet, and who are present at the starting signal for the match, shall be deemed to have played the match.
- iii In the event of a forfeit being declared during the week prior to the scheduled match, a representative of the team forfeiting, is required to contact the Match Secretary, Umpires Convenor and the team contact for the opposing team.
- iv Goals shall be recorded for a forfeit win 10 goals to winning team and nil goals to losing team in the event of a draw at the start of the semi-finals.
- v If neither team have five (5) registered players present and ready to play, the game shall be declared abandoned and no points will be awarded to either side.
- vi The club of any team forfeiting after 5pm on the Friday prior to the scheduled match date shall incur a fine of \$20 that must be paid prior to the team's next match.
- vi Teams who commit three (3) forfeits in one (1) season, will incur a fine of \$200 and will be eliminated from the competition forthwith (teams registered with a club, the affiliated club with incur the fine).

- 15 Players are only allowed to substitute five (5) times during a season. This will be monitored by the match secretary and they shall not be permitted to take part as a substitute in any other games for the season. Taking the court for any period of time for another team, is classified as a full game.
- 16 Any team found playing an unregistered or ineligible player or has no names on the score sheet, will lose two (2) competition points.

#### 17 Playing for other teams

YOU CAN PLAY for another team if they are short, ONLY:-

- i IF you are in the 11 & 12 years divisions, you can play in your division or one division above your age group; OR
- ii IF you are in Junior "B" you can play with either Junior "B" or Junior "A" teams; OR
- iii Players may play in one division higher than their own. Players in Junior A subbing into Senior division must be 13 years or older and have Parents or coach's permission. Players priority is to play in their registered team first if asked to sub in another team playing at the same time slot. Subs cannot play in any finals.

18 NO PLAYER SHALL PLAY IN THE JUNIOR DIVISON UNTIL THE YEAR OF THEIR 10<sup>th</sup> BIRTHDAY. The grading of 10 year olds into Junior Netball or Net Set Go Divisions will be made by clubs and the NVNA grading committee.

#### 19 Points Score

Competitions shall be conducted on points score basis and semi-finals, finals and grand finals shall be played.

The following points will be given to teams for:-

# Points will be deducted on the day from teams who fail to meet their canteen duties. These points will be equal to a forfeit

#### 20 Wet Weather

Wet weather games are considered as games played by all players registered prior to that date.

In the event of wet weather, cancellation of matches shall be broadcast on the Associations current electronic media, Facebook/website. A decision will be made on the morning of play, one (1) hour prior to commencement of games.

The following will apply due to inclement weather:-

- i) no game due to wash out 2 points each;
- ii) game called off <u>before or during half time</u> 2 points each;

iii) game called off <u>after commencement of second half</u> — the team leading at the time the Umpires Convenor calls off the game, gets the 4 points.

<u>Note</u>: It is the responsibility of the Umpires Convenor to abandon play due to wet weather.

# 21 Injury Time

No injury time will be added during games **<u>EXCEPT</u>** for semi-finals and grand finals when the following rule will apply:-

Umpires shall apply the time rule for injury and illness as stated in the Netball Australia Rule book. Timekeepers are responsible for stopping the clock when the umpire indicates time and notifying the umpire when the specified time out period has ended. The clock should be restarted on the umpire's whistle to restart play.

# 22 Semi-Finals and Grand Finals

- i To be eligible to participate in semi-finals and grand finals, players must have played in at least half (1/2) the competition matches with that team. Extenuating circumstances may be considered by the Executive prior to the day of the match.
- ii Experienced umpires will be appointed to umpire semi-finals and grand finals where possible.
- iii If two or more teams finish on equal points after the final round of matches, positions for semi-finals, shall be decided by a goal average to decide the winner.

Goal Average = <u>total number of goals</u> total number of games

- iv Semi-finals and grand finals shall be individually timed and scored by 2 individuals appointed by NVNA.
- v If there is a draw in semi-finals and finals, a two (2) minute interval shall be taken:
  - a) during the interval players may leave the court, the score will be verified with the scorers and the teams change ends. During the interval there may be substitutions and/or team changes;
  - b) Two (2) seven (7) minute halves will be played to determine a winner. After the first seven (7) minutes, the teams will change ends with no time out permitted. No substitutions or positional changes shall be allowed during the changeover;
  - c) if still a draw at the end of the 14 minutes, play continues and the first team to score a two (2) goals advantage, shall be declared the winner;
  - vi Positions for semi-finals play:-*First Semi Final* 1st place plays 4th place

Second Semi Final 2nd place plays 3rd place

Winners of each semi-final will play each other in the Grand Final.

vii Any team found playing an unregistered or ineligible player in the semi-finals, finals or grand finals, will be considered to have <u>lost that match</u>.

#### 23 *Protests, Complaints, Reports*

- i Any protest, complaint or report should be made an Member Protection Information Officer (MPIO).
- ii The Executive shall set up a Complaints Committee to deal with any protest, complaint or report, if necessary, and the persons concerned in the occurrence shall have the right to attend the meeting of this Committee, for the purpose of stating their case.
- iii In the event of any protest, complaint or report being found by the Complaint Committee to be justified, the following penalties may be imposed:
  - a) order a match to be replayed; OR
  - b) award the match to the non-offending team; OR
  - c) recommend to the Executive Committee that any team, player, umpire, coach, member or spectator be reprimanded, suspended or disqualified.

# 24 Awards on Presentation Day

All winners and runners-up of each grade will receive an award.

The main trophies to be awarded will be:-

- The Marion Wood All-Rounder Perpetual Trophy supports the Association above and beyond the call of duty;
- Club Person of the Year;
- Umpire of the Year;
- Sara Murton Award; and

Other trophies may be awarded as per the discretion of the Committee.

#### 25 Smoke Free Zone

Please note that the Nambucca Valley Netball Courts are a smoke free zone.

# 28 No eating on court

No players are to eat on court whilst playing, ie no chewing gum.

29 No moveable or portable structures are to be erected on the hard courts due to damage to the surface.
